

Applying for Federal Financial Aid (Pell, Loans, Work-Study)

- 1. Complete and submit the Free Application for Federal Student Aid (FAFSA) at studentaid.gov for the Fall 2025 complete the 2025-2026 FAFSA
- 2. Create an **FSA ID and password** for you and your parent, if applicable. This is used to sign the FAFSA.

For the 2025-2026 FAFSA you will need to provide consent to transfer tax information from the IRS: if you do not you cannot receive Title IV Financial Aid.

If you are not able to transfer IRS Data to the 2025-2026 FAFSA, you will need:

- your 2023 Federal tax return
- your parents' 2023 Federal tax returns, if applicable
- untaxed income information

Remember to list Erie Community College on the FAFSA for Colleges to Notify(Section 4)

An e-mail message will be sent within three to five business days with directions for viewing your **Student Aid Report (SAR)**. Review this carefully. Make any necessary corrections at <u>studentaid.gov</u>.

If additional information is required, the Office of Financial Aid will notify you at your SUNY Erie email.

Applying for NYS Aid (TAP, APTS, Excelsior Scholarship, Part-Time Study Scholarship)

Tuition Assistance Program (TAP)

Take the link on the confirmation page of your FAFSA. If you miss this link you will need to wait five business days before applying at www.tap.hesc.ny.gov/totw.

You must first create a username and personal identification number (PIN).

Information will be transferred from your FAFSA application (Independent Students only) Parent information needed:
Name, DOB, S.S.# and NYSDL#
2023 NYS tax return (IT-201) line 37

You will receive a TAP award/denial notice within 3 - 5 weeks.

Remember to list SUNY Erie Community College on the TAP Application.

Aid for Part-Time Study (APTS)

Aid for Part-Time Study (APTS) provides grant assistance for eligible part-time students enrolled in approved undergraduate studies.

EXCELSIOR SCHOLARSHIP

This program covers tuition for eligible SUNY students.

Apply at www.hesc.ny.gov/excelsior

NOTE: Applications available at select times of year.

To be eligible you must:

- ➢ Be a NYS resident
- > Be a U.S. citizen or eligible non-citizen
- ➤ Have a combined federal adjusted gross income of \$125,000 or less

NOTE: You must complete at least 12 credits per term and 30 credits per year.

Part-Time Scholarship

This program provides scholarships to part-time students who attend a community college.

Students can receive up to \$1500 per semester for up to 2 years.

Apply at www.hesc.gov

NOTE: Applications available at select times of year.

To be eligible you must:

- > Be a NYS resident
- ➤ Be a U.S. citizen or eligible non-citizen
- ➤ Have a combined federal adjusted gross income of \$125,000 or less

NOTE: You must complete at least 6 credits but less than 12 credits per term.
